08/11 ELECTION OF CHAIRMAN

13/11 PREVIOUS MINUTES: (Minute 01/11 refers)

14/11 MATTERS ARISING: (Minute 02/11 refers)

15/11 TREASURER'S REPORT (Minute 03/11 refers):

Maintenance:

- 1) Heating the roof void and individual water heaters. Mr Hunt is pursuing this. Mrs Collins will pass on some information she has.
- 2) Store Cupboard. The committee agreed that this needs sorting out again. A date will be agreed with the Social Club and when what can be disposed of has been what is used infrequently can be put at the back of the store or on top shelves. It may be useful to remove a lower shelf to increase floor space? Critical equipment – tables, chairs, cleaning equipment to be easily and safely accessible. The cupboard doors to be accessible as well, if possible. Mr Hunt suggested a small working party, 2 from the village hall committee and 2 from the Social Club. He is willing to take part.

MR Michael Carr has expressed interest in joining the committee again now he has retired and has the time to commit. The committee agreed he should be co-opted as soon as he is ready to join us until he can be voted on at next year's AGM.
